






Key Items in RFA	Notes (page, details, what is unclear)
What is the "crux" of this RFA? In other words, what is the EPA looking to achieve through the allocation of funding?	<ul> <li>They want trees planted in communities</li> <li>Low income</li> <li>Urban communities are the focus</li> <li>5-year project (Sustainability)</li> <li>Increase of parks and green spaces in target communities</li> <li>Equity &amp; Health disparities</li> <li>Economic development - holistic</li> <li>Education</li> <li>Connectivity</li> <li>Social Determinants of health</li> </ul>



Key Items in RFA	Notes (page, details, what is unclear)
What groups are eligible to apply	State gov, local gov, tribes, non profits, colleges, CBOs
Award info (how many, how much \$), deadline	\$1B total, \$100k-\$50m, Who gets \$50m? Partnerships are encouraged and could be a reason for more \$
What types of projects are eligible?	<ul> <li>Getting community input/planning/process</li> <li>Parkway development (restoration, planting new horticulture, beautifying, trees, etc.)</li> <li>Mitigation- for sustainability and runoff prevention/ canopies</li> </ul>
Match requirements	Dollar for dollar requirement     In kind is OK (such as staff time, volunteers)     100% waiver possible - based on who the project is helping the right community (use EJScreen tool)
Formatting requirements	7-page limit, single spacing, 1-inch margins, smaller font tables?
How do you apply?	Online - UCF grants portal?
Key components of narrative	Project Summary (100 words) Capabilities & capacity
