Lesson 3A3:

Request for Applications (RFA) Alignment Worksheet

The worksheet is intended to help community organizations evaluate the fit between the funder's priorities and those of the organization/community. Consider the following questions:

WHAT ARE THE ELIGIBILITY CRITERIA LISTED IN THE RFA?

WHAT IS THE FUNDER'S PURPOSE OR GOALS/OBJECTIVES IN ISSUING THE RFA? WHAT CONCEPTS OR IDEAS ARE EMPHASIZED?

EXAMINE THE GOALS/PRIORITIES OF YOUR ORGANIZATION'S WORK IN LIGHT OF THE FUNDER'S OBJECTIVES/PRIORITIES AS EXPRESSED IN THE RFA. IN WHAT WAYS DO THEY ALIGN? IN WHAT WAYS DO THEY DIFFER?

WHICH COMPONENTS OF YOUR ORGANIZATION'S CURRENT OR ANTICIPATED WORK MIGHT QUALIFY FOR FUNDING? IF MORE THAN ONE PROGRAM MIGHT BE A FIT, WHICH ONE APPEARS TO ALIGN BEST WITH THE FUNDER'S PRIORITIES AND THE GRANT TIMELINE?

IS THE WORK YOU ARE CONSIDERING A NEW INITIATIVE OR AN ESTABLISHED PROGRAM? IF NEW, DO YOU HAVE THE CAPACITY TO IMPLEMENT IT? WHAT ADDITIONAL RESOURCES DO YOU NEED? IF IT'S ONGOING, WHAT IS YOUR TRACK RECORD WITH THIS WORK?

COMPETITIVENESS OF YOUR ORGANIZATION, TAKING INTO ACCOUNT THE ORGANIZATIONS THAT HAVE RECEIVED THIS GRANT PREVIOUSLY (IF APPLICABLE) AND THE FUNDER'S CURRENT PRIORITIES (10 = HIGHLY COMPETITIVE/GREAT CHANCE OF BEING AWARDED THE GRANT)
