

Lesson 8B: Budget Narrative Template

General tips for writing a strong budget narrative

- Clearly state your assumptions
- Show your calculations and don't leave any 'dots' for the reviewers to connect
- Include letters of commitment/ quotes from consultants, vendors and contractors as attachments or append to the main Budget Narrative in PDF form
- If you are unclear about how to categorize an expense, or whether a certain expense is eligible, reachout to a program officer and/or check the "frequently asked questions" documents or website, if one exists
- Be as detailed as possible, as space allows

F.2. CONTRACTUAL/CONSULTANTS ITEM02. THESE TYPICALLY INCLUDE EITHER INDIVIDUAL CONSULTANTS (LIKE A DATA ANALYST, OR GRANT WRITER, OR A GIS CONSULTANT... THAT SORT OF THING. MENTION THE RATE OF PAY, TOTAL NUMBER OF HOURS FOR THE CONSULTANT AND OTHER PERTINENT DETAILS. ITEMS IN THIS CATEGORY COULD ALSO INCLUDE VENDOR CONTRACTS (SUCH AS PAYING A LAB FOR A SERIES OF MONTHLY SOIL TESTS). G. Construction

G.1. CONSTRUCTION ITEM01. IN CASES WHERE THERE IS NO CONSTRUCTION COMPONENT OR CONSTRUCTION IS NOT ALLOWED, THIS CATEGORY CAN BE LEFT BLANK. IF YOU ARE INCLUDING CONSTRUCTION COSTS BASED ON A QUOTE FROM A GENERAL CONTRACTOR, THAT CONTRACTOR SHOULD BE NAMED, AND AN OVERVIEW OF THE WORK EXPLAINED HERE. IN ADDITION THAT CONTRACTOR SHOULD ALSO HAVE PROVIDED YOU WITH A WRITTEN QUOTE, WHICH SHOULD BE APPENDED AS A PDF TO THE BUDGET NARRATIVE. THE QUOTE SHOULD BE AS DETAILED AS POSSIBLE.

H. Other

H.1. OTHER EXPENSE01. EXPENSES IN THIS CATEGORY COULD INCLUDE PARTICIPANT STIPENDS, A VEHICLE LEASE, MEMBERSHIP FEES, A LEASE ON A VEHICLE... OR ANY OTHER ALLOWABLE EXPENSE THAT DOES NOT READILY FIT IN ANY OTHER CATEGORY.
